#### Jeffrey Dorfman

Jeffrey Dorfman is a professor of economics at The University of Georgia and currently serves as State Fiscal Economist for Governor Brian P. Kemp. He is the author of four books and over one hundred academic publications. His research focuses on the quantitative analysis of economic policies.



#### **Christy Sanders**

Christy Sanders is a an attorney with the Georgia State Financing & Investment Commission, Georgia Building Authority, and State Properties Commission. She advises these agencies on a range of issues but focuses on procurement, construction, and property transactions.



#### Marvin Woodward

Marvin Woodward was appointed as the Deputy Director of the Georgia State Financing and Investment Commission in April of 2019. He has over 37 years' experience in highway and building construction, project development and planning. *Mr.* Woodward is a graduate of Penn State University with a B.S in Civil Engineering.
