HB-137 Raises Bid Threshold for State and For Local Government

Current Law:

Requires state agencies, counties, municipalities, and school systems to provide public notice and public procurement for public works construction projects over \$100,000

New Law:

Raises limit to \$250,000 so construction projects valued at less than \$250,000 do not have to be publicly procured

HB 579 General Contractor Licensing

- Creates 45 day "grace period" allowing for renewal after expiration of license
- Licensing Board not required to verify college transcripts to determine if postsecondary education requirement is met – can verify through "other reliable means"

SB 68 – Tort Reform

- -Limits ability of plaintiff to suggest value of non-economic damages like pain and suffering
- -No longer required to file an answer to a suit if you file a motion to dismiss
- -Limits recovery of attorney's fees
- -Seat belt rule
- -No recovery for damages paid by insurance
- -Creates tort of negligent security so claims are limited



HB 92 – Changes to Law that Limited Increases in Assessed Values for Homestead Exemption Property

Legislation passed last year to restrict annual assessment increases on homesteaded property to the rate of inflation, voters approved constitutional amendment

Bill allowed local governments a one time opportunity to opt out

HB 92 allows local bodies to rescind their decision to opt-out at any time by April 30, 2025, for tax year 2025 and by March 1 of each year for tax years 2026 to 2029.

Includes incentive for school districts that do not opt out – sales tax rebates for construction materials used for capital outlay projects

Those that do opt out must include in every ad valorem property tax bill they issue a notice "in bold print" that informs the resident that the body has decided to opt out of the exemption and a telephone number they can call if they have concerns about that decision.

- Companies operated or owned wholly or in part by "foreign countries of concern" cannot bid or propose on state contracts
- Includes prohibition on contracts through 3rd party
- Applies to all goods and services but specifically mentions computers, printers, connecting cables, and interoperable videoconferencing services
- Scrutinized countries are set by federal law and include: China, Russia, Venezuela, North Korea, Iran, and Cuba









Income Tax Refund

HB 112

Creates one time tax refund for those who filed for tax years 2023 and 2024

Single/married filing jointly = \$250 refund

Head of Household = \$375

Married filing jointly = \$500




Lower Income Tax Rates

Accelerates tax cuts originally approved in 2022, reducing the income tax rate for individuals and corporations from 5.39% to 5.19% for 2025.


If certain financial benchmarks are met, the rate would fall to 4.99% by 2027 — two years ahead of the original schedule
